NOTIFICATION

No. ESS 529/76/1, dated Aizawl, the 26th. July, 1977. In exercise of the powers conferred by sub-section (1) of section 30 of the Mizoram Board of School Education Act, 1975 (Mizoram Act. No. 2 of 1976), the Lt. Governor (Administrator) of Mizoram is pleased to make the following rules, namely:—

- Short title. 1. These rules may be called the Mizoram Board of School Education (Appointment of President, Secretary and Controller of Examination) Rules, 1977.
- Definitions 2. In these rules, unless the context otherwise requires,—
 - (a) "Act" means the Mizoram Board of School Education Act, 1975 (Mizoram Act No. 2 of 1976);
 - (b) "Board" means the Mizoram Board of School Education established under the Act;
 - (c) "Controller of Examination" means the Controller of Examinations of the Board;
 - (d) "Government" means the Government of Mizoram;
 - (e) "President" means the President of the Board;
 - (f) "Secretary" means the Secretary of the Board;
- The Board 3. msy creat posts of President, Secretary and Controller of Examinations.
- (1) The posts of— (a) President; (b) Secretary; and (c) Controller of Examinations shall be deemed to have been created by the Board with effect from the date of constitution of the Board.
- (2) They shall be all whole-time Officers of the Board and paid from the funds of the Board, but shall be appointed by the Government under the relevant provisions of the Act. They shall perform such duties as required under the provisions

of the Act. the rules and the regulations made there-under and such other duties as the Board may from time to time require them to perform.

(3) The mode of recruitment of officers to file these posts, the qualifications and experiences required to be possessed by them and also the pay scales and allowances to be admissible to them under the Board shall be as detailed here-under.

Appoint- 4. (1) ment of President.

- (1) The person selected for appointment on contract service under sub-section (1) of section 15 of the Act shall be an eminent scholar with not less than twenty years of experience in the field of school and college education, out of which period he must have spent at least ten years in educational administration in a responsible capacity.
- (2) He shall be paid a fixed monthly salary as per agreement between him and the Government in addition to which he shall also be paid such allowances as admissible to Government scrvant of Mizoram holding a post carrying that salary.
- (3) Other terms and conditions of his appointment shall be in accordance with the agreement between the person appointed and the Government of Mizoram.

Appoint: : ment of Secretary

- 5. (1) The Secretary shall be appointed by the Government as provided in sub-section (1) of section 17 of the Act, on the same scale of pay as that of the Joint Director of Education with all allowances admissible from time to time in Mizoram.
 - (2) The person selected for appointment shall normally be a Master's degree holder (relaxable in exceptional cases upto the level of a Bachelors' degree holder, if otherwise found suitable, with post graduate degree or equivalent Diploma in Education/Teachers' Training). He must have not less than fifteen years of experience in the field of education out of which period, he must have spent not less than ten years in educational administration in a responsible capacity.
 - (3) The Secretary may either be appointed directly or may be appointed by deputation from the staff of the Education Department on foreign service terms provided that the person so deputed shall not be telow the rank of Deputy Director of Education or its equivalent post in Education Department.
 - (4) In case of appointment by deputation from Education Department the person so appointed may either opt for the scale of pay for the Secretary or may continue to remain in his scale of pay in the parent department.
 - (5) The term of deputation shall normally be two years which may, however, be extended on request from the Board.
 - (6) The Board shall also make necessary contribution towards his pension, leave salary etc., and he shall also enjoy all facilities of fringe benefits as enjoyed by him in his parent department during the period of his foreign service under the Board.

Appoint- 6. (1)
ment of
Controller of Examination

- The Controller of Examinations shall be appointed by the Government as provided in sub-section (1) of section (17) of the Act on the same scale of pay as that of a Deputy Director of Education with all allowances admissible from time to time in Mizoram.
- (2) The person selected for appointment shall normally be a Master's degree holder (relaxable in exceptional cases upto the level of a Bachelor's degree holder, if otherwise found suitable, with post graduate degree or equivalent Disloma in Education/Teachers' Training). He must have not less than ten years of experience in the field of education which should include at least three years of experience in work connected with the scholar-ship Examination conducted by the Education Department of the Government of Mizoram. Preferably, he should have specialisation in the field of Psychometry/Educational Measurement and/or practical experience/ training in the conduct of public examinations involving tabulation procedures, sample survey of results, evolvement of grace principles as we I as proper setting and moderation techniques.
- (3) The Controller of Examinations may either be appointed directly or may be appointed by deputation from the staff of Education Department.
- (4) In case of appointment by deputation from the Education Department the person so appointed may either opt for the scale of pay for the Controller of Examinations or may continue to remain in his scale of pay in the parent department.
- (5) The term of deputation shall normally be two years which may, however, be extended on request from the Board.
- (6) The Board shall also make necessary contribution towards the pension, leave salary etc, and he shall also enjoy all facilities of fringe benefits as enjoyed by him in his parent department, during the period of his foreign service under the Board.

Government may appoint Secretary & Controller of Examinations from among the Boards' Staff.

- No deputation allowance to employees of Mizoram Administration appointed in the Board.
- 7. Notwithstanding anything contained in these rules the Government may make appointment to any or all of these posts other than the President on specific recommend tions of the Board from among persons already serving under the Board.
- 8. No twithstanding anything contained in these rules, no deputation allowance shall be admissible to employees of the Government of Mizoram when appointed to the posts of Secretary and Controller of Examinations in the Board on deputation.
