Whereas by Notification No. LAD/A/-54/77/18 dated 21st September, 1977 issued under sub-rule (2) of rule 125 of the Mizoram Autonomous District Council (Constitution and Conduct of Business of the District Councils) Rules, 1974 published in Mizoram Gazette Extra-ordinary on the 21st Sept. '77, every constituency in the Pawi Autonomous District was called upon to elect a member for constituting the new District Council.

Now, therefore, in exercise of the powers conferred by sub-rule (2) of rule 134 of the Mizoram Autonomous District Councils (Constitution and Conduct of Business of the District Councils) Rules, 1974, the Lt. Governor (Administrator) of Mizoram is pleased to appoint with respect to the said election :—

- (a) The 11th October, 1977 as the last date for making nominations;
- (b) The 12th October, 1977 as the date for scrutiny of nominations ;
- (c) The 1st November, 1977 as the date on which poll shall, if necessary, be taken ;
- (d) The 8th November, 1977 as the date before which the elections shall be completed.
