NOTIFICATION

No. 318/MIZ/78 (1)—Whereas the President has, by notification published in the Gazette of India, on the 16th June, 1978, called upon the members of the Electoral College for the Union Territory of Mizoram to elect one member to the Council of States;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 39 of the Representation of the People Act, 1951, the Election Commission hereby appoints with respect to the said election:—

- (a) the 23rd June, 1978 (Friday), as the last date for making nominations;
- (b) the 24th June, 1978 (Saturday), as the date for the scrutiny of nominations;
- (c) the 26th June, 1978 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 3rd July, 1978 (Monday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 6th July, 1978 (Thursday), as the date before which the election shall be completed;
