NOTIFICATION

No. ESS. 10/77/49, the 15th May, 1980. In exercise of the powers conferred by Rule 20 of the Deligation of Financial Powers Rules, 1978, the Lt. Governor (Administrator) of the Union Territory of Mizoram, with the previous approval of Government of India, Ministry of Education & Culture vide their No F.8-10/79—Sch. 6 dated 7.4.1980 with the concurrence of the Integrated Finance Division vide their U.O. No. 1615—IFD/80 dated 26.2.1980 and Planning Commissios U.O, No. M. 13018/9/79—Edn..dated 17.3.1980 is pleased to make the following Rules, namely:—

1. SHORT TITLE, APPLICATION & COMMENCEMENT:

- 1) These rules may be called the Mizoram Scheduled Tribe and Scheduled Caste Students (Special Scholarships) Rules, 1980.
- 2) These rules shall be applicable to the whole of Mizoram.
- 3) They shall come into force at once.

2. ELIGIBILITY:

- 1) The Special Scholarships under these rules shall be admissible to boys and girls belonging to Scheduled Tribes and Scheduled Castes, provided their parents are parmanent residents of Mizoram.
- 2) The Special Scholarships under these rules shall be tenable for prosecuting recognised courses of studies in recognised educational institutions within Mizoram.
- 3) Subject to availability of funds in the budget, the selection of candidates shall be made strictly on merit-cum-poverty basis. No student whose parent's or guardian's annual income exceeds Rs. 9000/- (Rupees nine thousand) shall be eligible for special Scholarship under these rules.
- 4) The Special Scholarships awarded under these rules shall not be combined with any other special or general scholarship.

3. VALUE OF SCHOLARSHIP:-

- 1) The value of the Scholarship at the Middle School stage (i/c Classes IV to VI) shall be Rs. 10/- p.m. and at the High Scholl stage (i.e. Class VII to Class X) Rs. 15/- p.m.
- 2) The value of the Scholarships as specified in sub-rule (1) is exclusive of tuition fee.

4. APPLICATION :-

- 1) Students desiring to avail of the Scholarship under these rules shall be required to submit their applications in the precribed form in the Appendix to these rules to the Director of Education, Mizoram through the heads of the Institution concerned.
- 2) Each application will have to be supported by the following documents:-
- i) Tribe/Caste Certificate.
- ii) Mark Sheet of the preceding Annual Examination. (The marks obtained in the preceding promotion/public examination will be the basis regarding academic merit of the candidates).
- iii) An income certificate of parent or guardian.
- 3) A certificate from the Deputy Commissioner or the Sub-Divisional Officer or any Gazetted Officer, regarding the income an Tribe/Caste of the perent/guardian of the candidates shall have to be furnished in support of income and Tribe/Caste.
- 4) Director of Education or a Committee constituted for the purpose shall make final selection in respect of award of these Scholarships.

5. CONDITION FOR AWARD: -

- 1) The Special Scholarships will be awarded annually for a period not exceeding 12 (twelve) months subject to the general condition of good conduct and satisfactory progress of the Scholarship.
- 2) These special Scholarships may be cancelled or suspended at any time and for such period as the Director Education may consider fit, when the Scholarship holder has by reason of his default, failed to make satisfactory progress in his studies or has been guilty of mis-conduct or have taken part in subversive activities.

6. RENEWAL OF SCHOLARSHIP:-

Subject to the availability of funds in the Budget, satisfactory conduct and progress in studies, and the income of the parent/guardian remaining within the permissible limit, the Director of Education shall sanction renewal of Scholarships awarded in the preceding year, for the remaining years of the course of study in a stage, in respect of each School Scholar.

7. POWER TO AMENDMENT:

The Lt. Governor (Administrator) of the Union Territory of Mizoram may modify any of these rules at any time except provisions relation to quantum of scholarship and the income limit of perent/guardian respectively for which prior approval of the Government of India shall be necessary.
