ANNEXURE - I

Terms, conditions and duties of Wild Life Advisory Board under the Govtinon Mizoram will be as follows:-

1. The Board shall meet at least twice in a year.

- 2. The Board shall regulate its own procedure (including the quotum.)
- 3. No act or proceeding of the Board shall be invalid merely by reason of the existence of any vacancy therein or any defect in the constitution thereof or any irregularity in the procedure of the Board, not effecting the merits of the case.
- 4. Duty of the Board is to advise the Govt. of Mizoram in the following matters:
- (a) in the selection of areas to be declared as sanctuaries, National Parks, which is game reserves and closed areas and the administration thereof.
 - (b) in formulation of the policy in granting licenses and permits under the Wild Life (Protection) Act, 1972.
 - (c) in any matter relating to the amendment of any Schedule and
 - (d) in any other matter connected with the protection of Wildlife, which may be referred to it by the State Government.

The Non-official members of the Board are entitled to DA/TA at the rate admissible to Grade 1 Officers for performance of the above duties.
