- 2. The terms of reference of the Committee shall be as follows:
 - (1) To indentify new items of tax and non-tax revenues that may be imposed with a view to increasing the over-all State Revenue.
 - (2) To review the existing Taxation Laws in the State and to suggest its rationalisation and modification with particular reference to:
 - (a): the incidence of Taxation of the various classes of people and taxable capacity
 - (b): the need for finding additional resources for the development programmes of the State.
 - (c): the scope of additional resources mobilisation both in the agricultural and non-agricultural sectors.

- (3) To suggest changes in the tax administration with a view to simplification and checking evasion and maximising collection.
- (4) To examine the existing non-Tax revenue and to recommend measures to be taken to ensure that the State Services and departmental undertakings are run economically and with maximum productivity.
 - (5) To study and recommend steps to be taken for effective recovery of arrear dues under the existing Laws.
 - (b) To examine the tax system of some other States which have succeeded in mobilising larger resources.
 - (7) To make any other recommendation on connected and relevant matters which may not be governed by the aforesaid terms of reference.
- 3. Non-official and outstation members shall be entitled to TA/DA as admissible to Grade I Govt. officers of Government of Mizoram and as admissible under Rules of the Mizoram Salaries Allowances and pension of Members of Legislative Assembly Act, 1987.
- 4. The Committee shall submit its report within six months from the date of its constitution.
