- LOCATION :** It is situated in the North-western corner of Mizoram along the River Langkaih. That is between 92 deg 15'00" long and 92 deg 25'00" long and 24 deg 51'00" lat. and 24 deg 10'00" lat.
- STARTING POINT :** Boundary pillar (B.P) No. 1 is fixed at the North-western corner of the town area nearby the river Langkaih from here the boundary line starts — i.e. 92 deg 20'26 deg 8" and 24 deg 9'14.5" lat.
- NORTHERN SIDE :** The boundary line runs towards eastern along the River Chengkawl upto a confluence where B.P. No. 2 is fixed at 92 deg 21'4.4" long and 24 deg 9'18.7" lat.
