With a view to speeding up of works relating to Relief and Rehabilitation within the purview of the Memorandum of Settlement between the MNF and the Govt. of India in 1986, Pu Lalthlamuana, Under Secretary, Relief and Rehabilitation Deptt. will also look after the function of the Welfare Officer to assist the Director, Relief and Rehabilitation until further orders.
