(5) Director, Agriculture — Member
(6) Registrar-Coop. Society — Member
(7) Chairman, Rural Bank — Member

The main functions of the state fund would be :-

- (a) to authorise the fund to act as a co-insurer to the extent of 33.1/3% in respect of Crop insuarance schemes intorduced in the state.
- (b) to administer the in-flow of fund by way of premium income and out-flow by way of claims.
- (c) to ensure proper and adequate conduct of crop cutting experiments on various crops taken up under crop insuarance.
- (d) to seed yield data for each crop and each defined area to G.I.C. as well as to the Indian Agril. Statistical Research Institute (IASRI), New Delhi.
- (e) to ensure wide publicity of the scheme, and
- as required under the Insuarance Act. 1938. The State Crop Insuarance Fund would operate through the Bank Account as being presently done in the case of IRDP to have operational flexibility and avoid delay in the settlement of claims. However, no claims would be settled by the State Crop Insuarance Fund without the prior clearance from the General Insuarance Corporation.
