No. B. 11014/1/90-F.Est, the 16th April, 1990. The Governor of Mizoram is pleased to constitute a Pay Commission the membership of which will be notified separately, the terms of reference of the Pay Commission will be as follows:—

- (1) to examine the present structure of pay and conditions of service keeping in view the recommendations of the Fourth Central Pay Commission and the decisions of the Government of India thereon.
- (2) to examine anomalies if any in the pay structure arising out of the implementation of recommendations of the Fourth Pay Commission and subsequent revision of pay of certain posts and to suggest measures for removal of genuine anomalies, if any, while recommending new structure of emoluments.
- (3) to examine the special pay and other allowances, concessions including leave travel concessions and benefits in kind which are available to the employees in addition to pay and to suggest changes which may be desirable and feasible.
- (4) to make recommendations on the above having regard inter alia to the prevailing pay structure under the Central Government, neighbouring State Governments, etc., the economic condition of the country, the financial position and resources of the State Government, the recommendations of the Ninth Finance Commission, the pattern of allocation of revenues from the Centre to the State, and the demands thereon such as those on account of developmental planning and the impact of pay revision on the various sectors of economy of Mizoram.

The Commission will devise its own Procedures and may appoint such Advisers, Institutional consultants and experts as it may consider necessary for any particular purpose. The Commission may call for such information and take such evidence as may be considered necessary. The different departments of the State Government and offices subordinate to them will furnish such information, documents and other assistance as may be required by the Commission.

- 3. Tee commission will make an estimate of the cost involved in implementing their recommendations and suggest measures for avoidance of wasteful expenditure and other measures for economy. The Commission will also suggest measures for promoting efficiency.
- 4. The Commission will submit their recommendations as soon as practicable, but preferably within a period of six months from the date of order.
- 5. The Commission may submit interim recommendations; if found necessary or if so desired by the Government:
