Subject :— CONSTITUTION OF MIZORAM STATE CALAMITY RELIEF FUND.

No. R. 13016/2/90-REH, the 26th April, 1990. In pursuance of the recommendations of the 9th Finance Commission, the Governor of Mizoram is pleased to set up a Calamity Relief Fund for the State of Mizoram for meeting all relief expenditure on Natural Calamities. This fund will have an existence separate from the general revenue of the State and contributions to this fund will be made by the Centre and the State of Mizoram in the course of the year in equal quarterly instalments. The fund will be kept in the State Bank of India, Aizawl and will be administered by the State Level Committee.

2. Contribution to the fund by the Government of India will be to the extent of 75 per cent in the form of Non-Plan Grant. The balance of 25 per cent shall be contributed by the Government of Mizoram out of its own resources.

3. In respect of State Government's share of expenditure provision of fund will be made in the State Budget and the amount required from time to time shall be got sanctioned for depositing into the bank account.

4. Following the creation of the fund, it will be the responsibility of the State Government to meet all expenditure arising out of Natural Calamities from out of this fund. The yearly addition to the fund as well as the accrual of interest thereon should be used to meet the requirements. No further Central assistance would be available for this purpose.

5. The money put into the fund in a year and remaining un-spent in that year or in subsequent years would be available to the State at the end of the 5th year of thereafter for being used as a resource for the next Plan.

6. Further, the Governor of Mizoram is pleased to constitute a State Level Committee headed by the Chief Secretary of the Government of Mizoram to operate the fund.

8. The State Level Committee shall decide on all matters connected with the financing of relief expenditure.

9. The State Level Committee will fix the norms of assistance in the eventuality of natural calamities, and will ensure its proper utilization.

10. The member-Secretary of the State Level Committee shall maintain detailed account of the receipt and expenditure in respect of the fund in Central Treasury Rules form 4 and all vouchers shall be properly maintained for audit. At the end of each financial year, the Member-Secretary shall submit report to the Government indicating the details of Transactions and the balance, if any, in the fund.

11. If it is found by the State Level Committee that in a particular year, the amount required is more than the same available in the fund, it may draw 25 per cent of the funds due to them in the following year from the centre to be adjusted against the dues of the subsequent year. The Central Government may however, at its discretion, allow a higher percentage of advance from the State's entitlement in the next year.

12. The State Level Committee may keep the Union Ministry of Agriculture informed of the amount of damages due to drought, floods etc. as well as the broad details of the relief works undertaken.
