- (i) The grade/formulation sof mixtures of N.P.K Fertilizer Mixture of Micro-nutrients Fertilizers and their specifications that can be allowed to be manufactures. Sale, Offer for sale stock or exibit for sale or distribute such mixtures in the State.
- ii) requirement of Laboratory facilities in a manufacturing unit including a unit manufacturing physical/mixture of fertilizers.
- iii) Method of drawal and analysis of samples.
- iv) any other matter referred by the Central/State Government/Central Fertilizer Committee to the Committee.
- 3. The Committee may, subject to be previous approval of the Central/State Government /Central Fertilizer Committee, make by laws fixing the quorum and regulating its own procedure and the conduct of all business to be transacted by it.
- 4. The committee may appoint one or more sub-committee, consisting wholly or members of the Committee or wholly of Co-opted members or partly of the members of the Committee and partly of Co-opted members. as it think fit, for the purpose of discharging such of its functions as may be delegated to such sub-committee or sub-committees by the State Fertilizer Committee.
- 5. The term of the committee shall be five years from the date of its publication in the official Gazette. The members of the Committee shall, unless seats become vacant earlier by resignation, death or otherwise, be entitled to hold office for 5 (five) years and shall be eligible for renomination.
- 6. The members of the committee and its sub-committee shall be entitled to draw travelling and daily allowances as specified below when they are called upon to attend a meeting of the committee or a sub-committee thereof
- (i) An Official member of the Committee or its Sub-committee shall be entitled to draw travelling and daily allowances in accordance with the rules of the Government under which he is for the time being employed and from the same source from which his pay and allowances are drawn.
