**BOUNDARY DESCRIPTION OF PROPOSED SOUTH DILTLANG
SOIL & WATER CONSERVATION RANGE :**
HEADQUARTER : SOUTH DILTLANG
AREA : 504 Km².

GEOGRAPHICAL LOCATION : The proposed Range of South Diltlang is located in the South-Western part of Mizoram, lying between 90°-40' to 92° East longitude and 22°-5' to 22°-40' North latitude. The total Geographical area of the Range is 504 Km² (Approx).

BOUNDARY DESCRIPTION :

The boundary description of proposed south Diltlang S&WC Range are as mentioned below.

NORTHERN SIDE :

The boundary line starts from the confluence of Tuichawng River and Chawngte River near Chawngte (P). The boundary then follows the Chawngte River upstream side in an easterly direction which is also the inter-District boundary of Lunglei and Chhimtuipui till it meets the confluence of Kawrawnglui with the Ngengpui River near Ngengpui Village in the East.

EASTERN SIDE :

The boundary line follows along the Ngengpui River in Southwards direction till it meets the River Chhimtuipui near Kawrthingdeng village. Again, the boundary line farther follows the said River in Southerly direction till it meets the International boundary line of Burma (Arakan) and India near Lawngmasu village.

SOUTHERN SIDE :

The boundary line follows the said International boundary in Westerly direction upto the source of Sanghatuilolui at South of Tuisentlang.

WESTERN SIDE :

The boundary line follows the downstream side of the Sanghatuilolui in Notherly direction and meets the Tuichawng River, near Parva village. Again, the boundary follows the Tuichawng River upstream side Notherly direction till it meets the starting point near Chawngte (P)
