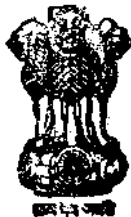

ANNEXURE.

CONDUCT AND MANAGEMENT OF PSLC EXAMINATION, 1990.

1. The MBSE will prepare question papers and answer Books and supply to the respective S.D.E.Os.
2. The S.D.E.Os will be responsible for the actual conduct and management of PSLC Examination, 1990 under their respective jurisdictions.

The duties and functions of the S.D.E.Os will be as follows :

- (a) Preparation of Roll Sheets.
- (b) Arrangement of Examination Centres
- (c) Supply of all Examination Materials to examination Centres including question papers and answer books received from the MBSE.
- (d) Conduct, Management and Supervision of examination at the Centres including appointment of examiners, Scrutinizers, Tabulator, Supervisors etc.
- (e) Publication of Results
- (f) Issue of Marksheets if required, in a cyclostyled form.
- (g) Any other works connected with the PSLC Examination.

3. COLLECTION OF FEES.

The S.D.E.Os will collect the examination fees as prescribed by the Board. Half of the total amount of fees thus collected may be retained by them to meet the expenditures. The remaining half will be submitted to the MBSE with a statement of Account to be adjusted at the end of the Examination.

4. PAYMENT OF EXPENDITURES.

All payments of expenditures including remunerations, etc. incurred by the S.D.E.Os will be made by the S.D.E.Os at the rate prescribed by the MBSE in the prescribed Bill Proforma to be supplied by the MBSE.

Such expenditures will be met from the fees retained by them. Any additional expenditure shall be met by the MBSE and any unspent amount shall be credited to the account of the MBSE. Immediately, after the publication of Results of the PSLC Examination, the S.D.E.Os concerned should submit to the MBSE the final statement of Accounts with connected receipt and payment vouchers for final adjustment and settlement of Accounts.

5. PRIMARY SCHOLARSHIP EXAMINATIONS : Each S.D.E.O will submit the Answer Books of the top 50 (fifty) candidates of the PSLC Examination for final evaluation by the MBSE. The MBSE will publish list of eligible candidates for the award of Primary Scholarships as usual.
6. One steel almirah each (big size 6'x3') may be purchased by each S.D.E.O. from the fees collected.
7. Remunerations may be paid at the rates mentioned below for the extra works involved in the conduct of the PSLC Examination.

8. No DA/TA should be paid to Examiners, Scrutinisers, Tabulators, Supervisers, Invigilators, etc.
9. All the necessary expenditures, such as remuneration of Centre Superintendents, Invigilators, Clerks and IV Grade employees of the Exam Centres and all other stationery requirements of the Exam Centres should be paid out of Centre fees collected by the Centre-Superintendent.
10. Certificates should not be issues by the SDEOs Office, Individual schools should issue Transfer Certificates based on the results published by the SDEOs,
11. Each SDEO Office should maintain complete records of the Examination results for the schools under his jurisdiction, Each individual school should be supplied with the copies of its Results.
