Whereas it is necessary to protect the economic interest of the native marginal farmers of Mizoram, engaged in the production of iskuts and other indigeaneous agricultural produces of the land within Mizoram from unhealthy marketing competition with some middlemen and outsiders, not being the native of Mizoram.

And whereas for this purpose it is expedient to prevent total outflow of the indigeneous agricultural produces of the land, including iskuts beyond and outside the Inner Line of Mizoram, as it is economically detrimental to major section of the natives of Mizoram.

Now, therefore, in exercise of the powers conferred under section 7 of the Bengal Fastern Frontier Regulation, 1873 (V of 1873), the Governor of Mizoram is pleased lo prohibit movement of iskut and other Agricultural indigeneous produces being cultivated and harvested in and on the land within Mizoram beyond the Inner Line of Mizoram, by any individual or agency, save and except on a specific permit to be issued by the Director of Trade & Commerce of Govt. of Mizoram or any other officer or authority as may be specified by Government by a notification published in the Mizoram Gazette, and any violation of this order by any individual or agency shall be dealt in the like manner as in the case of crossing the "Inner Line" by an individual without a permit under the Regulation.

Explanation – The term indigeneous agricultural produces shall mean and include such other items (iskuts already declared so by the notification) as may be notified by the State Government from time to time for the purpose of the prohibition issued hereby.

This shall remain in force initially for a period of three years from the date of its issue.
