### AIZAWL TOWN BOUNDARY DESCRIPTION

Starting Point : Starting Point is at the confluence of Sele Lui and Ramri Lui, trijunction of Sihphir Durtlang and Muthi villages jurisdiction. The north-eastern corner of Aizawl Town Area is used as a starting point where the boundary Pillar No.1 stands just on the western edge of river Tuipawl lui within the jusdiction of Durtlang Village.

NORTH

: From the Starting Point, the boundary line directs the boundary pillar No.2 fixed at Leivawkkuang kawn cast of Sibphir village hear Hmuphlui tlang. The line then runs north west crossing Yangvat Lui through Thanupa thlam it then crosses Tuilut. Ngura Lui, Sentlang Lui and Sakei Lui and passes Ramthanga's garden Vailui, Daihnaikawrte Zathuama's Fish Pond, the Dakla Lui and meets B.P.No.3 fixed at the saddle in the garden of Zotawna. The line runs from B.P.No.3 towards north passing the saddle called "Zahmuaka huan thlamkawn" then crosses Awmpuii Lui, and Mota Lui upto B.P.No.4 fixed at Kanghrep Kawn. The line runs the same direction and meet Bunglui hnar at about 400 metres cast of Sethupkawn. The line follows up the stream upto Sethupkawn where B.P.No.5 follows down Sethupkawn. It bends from about 200M west of Sethupkawn to south west upto B.P.No.6 fixed at Tlangchengkawn. The line then directs Theihai kawn and follows a tributory of Chhimluang lui upto the junction of Chhimluang lui. The line follows down the later upto the confluance with its tributory which starts from Dil kawn B.P.No.7 is fixed here. The line than follows up tributory upto Dil kawn.directB.P.No. 8 fixed at the western side of Sihohir from where tlaklam Lui starts.
