The terms of reference of the State Level Committee will be as follows :

1. To undertake the study of identify the potential of relevant plasticulture applications, such as, pond lining, canal and field chhannel lining plastic pipes for water conveyance, agricultutal pump sets, drip irrigation sprinkler mulching, nursery bags low tunnels, plastic crates, pusa bins, cap covers etc.

2. To prepare targets and action plan for promotion of relevant plasticulture applications in the state during 8th plan.

3. To identify areas where external support particularly from NCPA, central Government Ministries and other bodies is required for promotion of plasticulture applications in the state.

4. To actively collaborate and interest with the state/Agricultural universities/ Plasticulture Development Centres set up by the NCPA. So that they can provide Technical inputs for Development of plasticulture in State.

5. To formulate suitable promotional programme for popularising Plasticulture in the State.

6. To recommend to the State Government for offering suitable incentive schemes, and olso waiving of sale tax etc. for plasticulture applications.
