No.D.11028/1/90-EDN (A&C), the 8th November, 1990. Whereas the Government of Mizoram finds it expedient to amend the Mizoram Management of Vanapa Hall Rules, 1984, the Governor of Mizoram is pleased to amend the said Rules as follows :

1. Short title, (1) These rules may be called the Mizoram Management of extend and Vanapa Hall Rules, 1984. commencement.
- (2) They shall have the like extent as the principle Rules.
- (3) They shall come into force at once on the date of publication in the Mizoram Gazette.

2. Rule 2(a) Definition 2nd para and rule 2(c) of the Mizoram Management of Vanapa Hall Rules, 1984 shall be superseded by the following :—

Rule 2(a) : “Commercial function” means a function organised by any party for the purposes of collecting money or fund. An advertisement type of functioning will also be regarded commercial function.

Nothing in these rules shall apply to a function organised by any Govt. Deptt. pertaining the benefit of sterilisation to the public under the family planning scheme despite the function is rightly an advertising type of function and such Govt. function will be treated as usual Govt. function.

3. Rule No. 3(1) and (2) of the Mizoram Management of Vanapa Hall Rules, 1984, shall be superseded by the following :

Rule 3(1) : Vanapa Hall shall be open for the use of official function on payment of hiring charges.

Rule 3(2) : Vanapa Hall shall be open for the use of non-official and commercial functions including political party functions on payment of hiring charges.

4. Rule No. 4. of the Mizoram Management of Vanapa Hall Rules, 1984 shall be superseded by the following :

**“PERMISSION FOR USING THE HALL AND CANCELLATION OF PERMISSION AND RESERVATION”**

Permission for using the Hall may be issued by the Chairman/Secretary of the Managing Committee or Board on receipt of such applications as per main Rule 5 on seniority basis in writing as far as practicable on condition that on no account function held at Vanapa Hall should cause obstruction to vehicular traffic and to the general public in the vicinity.

In case the Hall is urgently required for official function, the Chairman/the Secretary may cancel the reservation without assigning any reason thereof.

Full amount of advance for hiring the Hall may be refunded in case such cancellation is done before the commencement of a function at the Hall. Rate of refund of advance paid shall be fixed by the Managing Committee in case of cancellation after commencement of any function at the Hall.

6. Rule No. 7 of the Mizoram Management of Vanapa Hall clause (1) (a) and (b), clause 2(a) and (b) clause 3(a), (b) Rules, 1984, and (c) shall be superseded by the following :-

#### HIRING CHARGES

1. There shall be two kinds of hiring charges which shall be known as :—
  - (a) Non-Commercial function at the rate of Rs. 200/- (Rupees two hundred) only per hour or part thereof throughout the day or night respectively subject to a maximum of Rs. 1000/- (Rupees one thousand) only for full day or night respectively.
  - (b) For Commercial function :- The hiring charges shall be fixed at the rate of Rs. 400/- (Rupees four hundred) per hour or part thereof through out the day or night respectively subject to a maximum of Rs. 2000/- (Rupees two thousand) only for a full day or night respectively.

The above hiring charges are subject to modification as may be determined by the Managing Committee from time to time.

7. Rule No. 14 of the Mizoram Management of Vanapa Hall Rules, 1984 shall be superseded by the following:—

Management/Committee Board :- “There shall be two bodies for the Managing of Vanapa Hall known as Managing Board and a Managing Committee which should be constituted with the following members :—
