#### THE APPROPRIATION (NO. I) ACT, 1972

#### An Act

to authorise payment and appropriation of certain sums from and out of the Consolidated fund of the Union Territory of Mizoram for the services of the Financial Years 1972-73 (3.5.72 - 31.3.73)

#### Be it enacted by the

Legislative Assembly of Mizoram in the Twenty Third year of the Republic of India as follows :---

I. The Act may be called the Appropriation (No. 1) Act, 1972.

2. From and out of the Consolidated Fund of the Union Territory of Mizoram there may be paid and applied sums not exceeding those sepcified in column 3 of the schedule amounting to the sum of Seventeen crores ninety one lakhs sixty thousand seven hundred rupees towards defraying the several charges which will come in course of payment during the Financial year 1972-73 (3.5.72 to 31.3.73) in respect of the services specified in column 2 of the schedule.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union Territory of Mizoram by the Act shall be appropriated for the services and purposes expressed in the schedule in relation to the period from 3.5.1972-31.3.1973.
