Terms & conditions :--

- a) The terms of office for the above members of the Board shall be normally twoyears with effect from the date on which the Board is fully constituted. The members shall hold office during the pleasure of the-Lt. Governor of Mizoram.
- (b) The Board shall ordinarily meet once every three months.
- (c) The notice for the Board's meeting shall be issued at least fifteen days before the date of the meeting by the Secretary with prior approval of the Chairman.
- (d) A member shall cease to hold office if he is absent from three consecutive sittings of the Board without permission of the Chairman of the Board.
- (e) Six members shall form the quorum. If there be no quorum, the meeting shall be adjourned to a subsequent date. No quorum will be necessary for adjourning meeting.
- (f) In absence of the Chairman, the members present shall elect one of the members present to preside over that particular meeting.
