Application in prescribed form are invited from candidate who are citizen of India as defined in Articles 5 to 8 of the constitution of India and the citizenship Rules, 1956 for the undermentioned temporary posts in the office of the undersigned and will be received upto 15th November. 1972.

Application must be accompanied by copy of Treasury Chalan showing deposit of application fee of Rs. 5.00 (five) and Rs 2.50 (Rupees two and fifity paise only) in case of schedule tribes, Schedule caste, political suffurer and war Service personnel for posts mentioned at A, B & C and Rs.3/—(three) and Rs.1.50 (Rupees one and fifty paise only) in respect of schedule caste. Schedule tribes, Political sufferer and war Service personnel for posts mentioned at D & E below. The application fee in question is to be deposited under the head XXI Misc. Department Examination fee II Others. Application not accompanied by copy of Treasury chalan will, in no case be considered.

Candidates for all the posts mentioned below must be within the age limit of 18 years and 25 years on 1.8.72 which is relaxable by 5 years in cases of candidates belonging to schedule caste and schedule tribes.

There is no age bar for candidate who are in Government employ

The application must also be accompanied by attested copies of Certificates/testimonials etc. in support of their age, qualification, proficiency and characters.

Gandidates who are already in Government employ must apply through proper channel and applicants not already in Government employ should apply through Employment Exchange / or indicate Card No. in their application.
