3. Candidates should have a 1st. Class Master's degree from any recognised University with at least 5 years of experience of teaching and/or Educational Administration.

or

2nd. Class Master's degree from any recognised University with at least 7 years of experience of teaching and/or Educational Administration.

4. Candidates must possess a working knowledge of Mizo language.

5. Candidates should be less than 40 years of age on the 1st. December, 1972. The age limit is relaxable

by 5 years for scheduled Castes, Schedule Tribes and Ex-service candidates, and no age limit stands in case of persons already in Govt. service.

6. Applications must be accompanied with a Treasury Challan of Rs. 5/- (Rs. 2.50 for scheduled Castes, scheduled Tribes, Political sufferer and war service personnel) deposited into the Treasury under the Head "XXI Miscellaneous Department Examination fees-Receipt of the Govt. of Mizoram.

7. Fees are not refundable and no postal, money order or stamp will be acceptable in lieu of Treasury Challan.

8. Candidates when called for interview, will have to appear before the Interview Board at Aizawl at their own expenses.
