#### GUIDELINES FOR WATER CONNECTION

1. The sanctioning authority for water connection shall be the Government of Mizoram (Minister i/c PHE and the Secretary, PHE Department only.)

2. There shall be a prescribed application form obtainable from the Office of Executive Engineer, PHE, Aizawl Division.
3. All the requisite informations shall be filled up by the applicant, failing which the application shall summarily be rejected.
4. The duly filled in application shall be submitted to the Office of Executive Engineer, PHE, Aizawl Division No. I or the concerned Executive Engineer PHE.
5. The concerned Executive Engineer, PHE, will have on the spot verification for feasibility report and forward the application to the Government clearly stating its feasibility with recommendation or otherwise.
6. Measurement shall be taken after receipt of an application at least the rank of Junior Engineer putting his/her seal and signature on the space provided in the form.
7. Connection shall be given through supply tank only.
8. In case, where there is a plot of land but no supply tank was constructed at the proposed point a 'T' cluster connection shall be provided the applicants are not less than 7 families from the proposed point.
9. Supply Tank shall be constructed at the proposed point site as early as possible and 'T' cluster connection shall be shifted to the Supply Tank immediately. The shifting charges shall be borne by the connection holders.
10. Not more than one connection shall be given to a single house/building.
11. Connection shall be installed only after all connection fees etc. are deposited into Treasury by the applicant.
