- iii) To initiate, support, promote and co-ordinate preferably by establishing networks, such Research Deging and Development projects and programme, including demonstration projects, as are likely to be relevant to the specific objectives, problems, surveys and optimum utilisation of natural resources of the State, in institution and organisation of the State:
- iv) To prepare, or assist in the preparation of Science & Technology and Environment plans for the State:
- v) To advise the Government on policies and measures relating to the development & development of Science & Technology & Environment menpower resources:
- vi) To promote the popularisation of Science and the spread of a Scientific temper and attitude among the people of the States;
- vii) To supplement and complement the on-going technical efforts of the State Governments:
- viii) To inter-act with other State and National Science & Technology and Environment bodies having smilar or related objectives;
- ix) To identify priority areas of Science & Technology & Environment needed for long-term development of the State;
- x) If essential, to establish, or assist in the establishment of the infrastructure, in institutions, organisations etc. necessary to achieve the aforesaid objectives;

- xi) To take any other steps which are relevant to the application of Science & Technology and Environment to the problems of the State;
