Whereas the Government deems its expedient to extend adequate assistance within the limit of its financial resources in the shape of recurring and non-recurring Grants-in aid to the deserving Institutions or Organisations or individual War Widows and Ex-servicemen.

Now, therefore, in exercise of powers conferred upon him under Rules 20 of the Delegation of Financial Power Rules 1978, as amended or modified from time to time read with paragraph 4 of the Mizoram Adaptation of Laws Order (No-2) 1987, the Governor of Mizoram is pleased to frame the following rules to regulate the Grants-in-aid to Institutions or individual War Widows and Ex-servicemen for their resettlement, namely :-

- 1. SHORT TITLE AND COMMENCEMENT.
  - (i) These rules may be called the Mizoram Sainik welfare and Resettlement (Grant in aid to Ex-servicemen) Rules, 1991.
  - (ii) They shall come into force with effect from the date of publication in the Mizoram Gazette.
- 2. DEFINITIONS. IN THESE RULES, UNLESS THE CONTEXT OTHER-WISE REQUIRED :
  - (a) 'Dependent' means wife, parents or children below the age of 25 years;
  - (b) Ex-servicemen means a person, who has served in any rank (whether as a combatant or as a non-combatant) in the regular Army, Navy and Air Force of the Indian Union such as :-
    - (i) who has retired from such service after earning his/her pension, or

- (ii) who has been released from such service on medical grounds attributable to military service or circumstances beyond his control and awarded, medical or other disability pension,
- (iii) who has been released, otherwise than his own request, from such service as a result of retrenchment; or
- (iv) who has been released from such service after completing the specific period of engagement otherwise than at his own request or any way of dismissal or discharge on account of misconduct or inefficiency, and has been given a gratuity;
- (v) who has been a member of the Territorial Army and holding pension for continuous service or disability attributable to military service, and Gallantry Award winners; but it does not include a person who has served in the Defence service corps; the General Reserve Engineering Force, the Lok Sachayak Sena and the Para Military Force.
- (c) Government means the State Covernment of Mizoram;
- (d) Institution means recognised Institution;
- (e) War disabled means injury/injuries sustained in the war or other war-like military operations;
- (f) War-Widow means legally married wife of serviceman killed in action.

3. ELIGIBILITY AND PURPOSE OF GRANTS. The Grants-in-aid under these Rules are admissible for any ventures pursuing resettlement of War Widows, Ex-servicemen and their dependents such as :---

- (a) Construction of War Memorial Boys Hostel in Assam Regimental Centre, Shillong;
- (b) Vocational Training Centre in Assam Regimental Centre, Shillong,
- (c) Construction of Dwelling House for War Widows and next of kins of War Casualties hailing from Mizoram;
- (d) Army Wife's Welfare Association;
- (e) Grant of Cash Awards to the recipients of Gallantry/Meritorious service award winners;
- (f) Any other purpose for resettlement of War Widows and Ex-servicemen.

#### 4. CONDITIONS OF GRANT :

- (a) The grant shall be spent exclusively for the purpose for which it has been sanctioned;
- (b) All accounts relating to the specific grants made by the Government shall be subject to Audit by Government;

(c) The Organisation shall have no outhority to dispose or encumber wholly or partially any capital assets acquired out of Grant-in-aid.

SANCTIONING AUTHORITY. The Government shall be the competent 5. authority to sanction these grants under these Rules.

MODE OF SANCTION. Application for Grant-in-aid, depending on the merrit of the cases will be processed by the Home Department, Government of Mizoram through the Department of Sainik Welfare and Resettlement for sanction.

7. GOVERNMENT OF RESERVE RIGHT. The Government shall reserve the right of amendment to the provisions of these Rules.

8. The fund is made available under head "2235-Social Security & Welfare, 60-Other Social Security & Welfare Programme, 200-SS & A Board, 200 (1)-SS & A Board, 60/200 (1) (9) ( )-Grand-in-aid, Non-Plan".
