#### EXECUTIVE ORDER NO 15/91.

No. H. 11012/1/91-92/LAD/13-14, the 23rd May, 1991. In supercession of Executive Order No. 12/91 conveyed under Memo No. H. 11012/1/91-92 LAD/1 of 24.4.1991 and in exercise of the power conferred by section 6 of sub-section 2 of Chapter II of the Mara Autonomous District Council (Village Councils) Act, 1974 the Executive Committee of the Mara Autonomous District Council is pleased to extend the term of village council and court of N. Colony village council and Siaha vaipi Village council upto 31st, November, 1991 for the following reason 1) Election to Lok sabha Member and Member of Legislative Assembly are to be held on 12th June, 1991 in which all eligible voters are to exercise their franchise and as such it is not possible to prepare Electoral Roll and other matters for election to Village Councils within limited period.

2) Due to recent Cyclonic storm many Private houses were damaged at Saiha town and bring hardship to the people. For restoration of damages it is considered that atleast some months is required and as such it is felt inconvenient to hold election to village Council in such critical period.
