2. FUNCTION OF THE BOARD

(1) The functions of the Board shall be :-

- (a) to lay down policies for Soil & Water Conservation.
- (b) to devise ways and means for co-ordinating and periodically reviewing the work under the plans and for eliminating the difficulties in relation thereto;
- (c) to scrutinise the progress made under the plans;
- (d) to perform such other functions as may be specified by or under this Act.

(2) The Board shall prescribe the procedure including quorum for the conduct of its business.

(3) The member-Secretary of the Board shall :-

- (a) initiate formulation of rules, regulations monitor and evaluate plan schemes or programme implementation.
- (b) Conduct administrative control and keep the Board informed of the progress of works implementation from time to time.
- (c) scrutinise the plan so prepared by the District Committee and place before the Board for final approval at the State Level.

3. The State Government constituted for each district a District Soil & Water Conservation Committee and the Committee shall function under the policy directives of the Board.

4. FUNCTION OF THE DISTRICT COMMITTEE

(1) The functions of the District Soil & Water Conservation Committee shall be :-

- (a) to take steps to educate people in Soil & Water Conservation;
- (b) to direct the Soil & Water Conservation Officer to make a survey, collect data and prepare plans for the District or any part thereof and to perform functions incidental thereto;
- (c) to consider and approve the plans and so prepared.

- (d) to take steps to ensure proper execution of the plans including identification of the institution for specific work and to watch the progress of works there under;
- (e) to make recommendations to the Board for securing efficient executive of the plans;
- (f) to carry out the directives issued by the Board from time to time with regard to a plan;
- (g) to undertake a periodic review and appraisal of the plan; and
- (h) to perform such other function as may be specified by or under this Act.

(2) The District Soil & Water Conservation Committee shall prescribed the procedure including quorum for the conduct of its business.

The Soil & Water Conservation Officer shall execute the plans and perform such other function as may be specified by or under the Mizoram Soil & Water Conservation Act, 1990.
