Whereas it is necessary to protect the economic interest of the native marginal farmers of Mizoram engaged in the production of Ginger, chillies, sesame and Raw-cotton within Mizoram from unhealthy marketing competition with some middleman and outsiders not being the native of Mizoram.

And whereas for the purpose it is expedient to prevent total outflow of the indigenous agricultural produces of the land such as — GINGER, CHILLIES, SESAME and RAW-COTTON beyond and outside the Inner Line of Mizoram as it is economically detrimental to Major section of the natives of Mizoram.

Now, therefore in exercise of the powers conferred under section 7 of the Bengal Eastern Frontier Regulation, 1873 (V of 1873), the Governor of Mizoram is pleased to prohibit movement of Ginger, chillies, sesame and Raw-Cotton being cultivated and harvested in and on the land within Mizoram beyond the Inner Line of Mizoram by any individual or agency, save and except on a specific permit to be issued by the Director, Trade and Commerce, Govt of Mizoram or any other officer or authority as may be specified by Government by a notification published in the Mizoram Gazette and any violation of this order by any individual or agency shall be dealt in the like manner as in the case of crossing the "Inner Line" by an individual without a permit under the Regulation.

This shall remain in force, unless extended further, period of three years from the date of issue.
