- (4) To enable the O.S.D. to function effectively he will be provided with one vehicle and driver by the Director of Transport Mizoram who will bear the cost of POL, maintenance, etc. of the vehicle, and Supporting staff (clerical and Group 'D') by the Deputy Commissioner, Aizawl.
