With a view to ensuring effective co-ordination in planning, implementation and monitoring of plan schemes in Lunglei District, the Governor of Mizoram is pleased to constitute a High power Committee for Lunglei District with immediate effect and until further orders. The head-quarters of the Committee shall be Lunglei. The necessary infrastructure for functioning of the Committee will be provided by the Deputy Commissioner, Lunglei and the District planning Machinery under him. No salary or TA/DA bill will be admissible to the Vice Chairman who will draw his salary and TA/DA as M. L. A. from the budget of the Mizoram Legislative Assembly. The other non-official members of the Committee will be entitled to such allowances as are admissible to the non-official members of the District Planning and Development Board, Lunglei.

The powers and functions of the High power Committee shall be as follows:-

POWERS :

- i) To reallocate fund from one scheme to another within the district and within the Sectoral allocation, provided that in case the Sectoral new scheme is not identical in nature with the Scheme to be dropped, prior approval of the Govt. will be necessary.
- ii) To recommend to the Govt. re-allocation of fund from one Sector to another within the overall provision for the district,
- iii) To draw up calendar of work for various departments in the district and over-see their implementation;
- iv) To have authority to pass structure against/give Commendation to officers in the District in respect of their performance, which will have to be recorded in A. C. R. of the concerned officers by their respective superior officer as Reporting Officers;
- v) To make such recommendation to the District planning and Development Board or to the Govt. as deemed necessary in the interest of better planning implementation and monitoring and
- vi) To obtain information from any officers in the district regarding progress of plan schemes.

FUNCTIONS:

- i) To give guidance to the District planning and Development Board in formulation of plan proposals, implementation of programmes and monitoring;

- ii) Quarterly review and occasional review of District plan; and,
- iii) Any other function that the Government may allot from time to time.

The Committee shall meet at least once in three months. The Chairman and the Vice Chairman will have the power to co-opt any Govt. official (s) or any non-official (s) as members of the Committee for any particular occasion.
