The functions of the state Level Animal Welfare Board will be as follows :-

(a) to advise the state Government on measures to prevent unnecessary pain or suffering to animals generally and more particularly when they are being transported from one place to another or when they are used as performing animals or when they are kept in captivity or confinement.

(b) to encourage the formation of animal welfare organisation in any local area and to guide them in their working.

(c) to advise the Government on matters relating to the medical care and attention which may be provided in animal hospital.

(d) to advise the Government on any matter connected with animal Welfare or the prevention of infliction of unnecessary pain or suffering on animals.

The State Level Board should meet periodically atleast twice in a year and can form its own regulations regarding conduct of the meetings etc.
