### TERMS AND CONDITIONS OF THE PLANNING & DEVELOPMENT COMMITTEE OF THE DISTRICT COUNCILS

**A. SIZE OF THE COMMITTEE :-** The Committee shall be headed by Vice Chairman and should consist of 5 members (inclusive of Vice Chairman and Member Secretary). The Members Secretary should be an Official of Group 'A' Category from the concerned District Council area. Composition of the committee shall be as follows :-

**B. TENURE OF THE COMMITTEE :-** Tenure of the Committee shall be 3 years from the date of constitution of the committee which should count from the date of issue of formal notification. The members of the Committee shall hold Office at the pleasure of the Executive Committee of the concerned District Council.

**C. STATUS/ENTITLEMENT OF THE COMMITTEE MEMBERS :-**

- 1) Vice Chairman of the Committee shall be entitled to salary TA/DA and all other facilities as EMs of the District Council.
