(Mr. Chhoza's house) will be under Dairivaih while KNP Tea stall will be within Tipa 'V' Village Council. Acrossing BRTF road straightly and leaving Bus station under Tipa 'V' area, the boundary moves up along the approach road to Block Development Officer quarter towards a big tree of Jack still it reaches 18th AR compound thereby leaving Block Development Officer quarter under the jurisdiction of Dairivaih village council.
