No.G.12017/2/92-EDN: the 16th August, 1994. The question as to what procedure should be followed for determination of 12 years for promotion to Senior/Selection scale provided for in the Recommendation of PAC/89, has been under the consideration of Government. Though the PAC Report which was basically founded on he recommendation of National Commission on Teachers, such pay scales and benefits are extended to Teachers engaged in non-Govt. Schools like Deficit School as well. In the PAC report itself, there is no clear cut provision as to how such 12 years s to be computed for eligibility for promotion to Senior/Selection scale. In absence of such clear cut provision, it has come to the notice of Government that in certain cases, services rendered by a Teacher in purely Private institutions are also taken into consideration for determination of 12 years services, whereas such benefits are denied o other Teachers. As a result there are complaints from many Teachers on the matter.

In order to maintain uniformity for all teachers while making promotion to Senior Selection Grade scale provided for in the PAC report, it has been decided that only continuous service without any break rendered by a teacher in Deficit or Govt. schools as the case may be, should be taken into consideration for determination of 12 years. In other words, counting of 12 years will begin from the date of entry into either Deficit School or Govt. School uninterrupted by resignation or any other

break. It is further decided that two spells of service rendered under Deficit High Middle Schools will count for promotion to Senior Grade provided there is no break of service in between the two spells.

Consequent upon this decision, the ban imposed by Government vide Ne.F. 12011/1/92-EDN dt.3.3.92 is hereby lifted with immediate effect. However, promotions to Senior/Selection grade scales already made consequent upon implementation of PAC report by counting of services under private institutions should be cancelled and overdrawal of pay and allowances should be recovered from the concerned teacher under intimation to the Government.

It is further decided that promotion to Senior grade scale may be made under the Provision of PAC report on attaining 12 years as calculated above. However, no arrear of Pay and allowances shall be paid except for national fixation benefits due to financial constraint.

This issues with the concurrence of Finance Department vide their U.O.NO FIN(E) 48/94 dt.19.7.94.
