### Government of Mizoram Part II (A)

Resolutions, Regulations, Orders, Notifications, Rules and Acts, Award of Tribunal, Requisition, Acquisition and declaration relating to land and Forests etc. by the State Govt. and Head of Departments.

#### NOTIFICATION

No. B. 11015/7/95-TRP, the 16th November, 1995. Whereas in the recent past four fatal bus accidents took place near Baktawng, Kawnpui, Melthum, and Lengpui resulting in a huge loss of human lives and also subjecting a large number of passengers to severe hodily injuries;

Whereas such successive bus-accidents within a short span of time, greatly affecting the public life, health and tranguility warrant due cognisance of the matter by the Government;

Whereas the frequency of such and other types of vehicular accidents throughout Mizoram lately as well as in recent past appears to be alarmingly high arousing serious public concern to therefore and

Whereas it is considered expedient in the above circumstances and in public interest, to have an indepth study on causes and analysis of such motor-vehicle-accidents for the purposes of devising some effective measures for its prevention as well as towards formulating a scheme as contemplated in section 135 of the Motor Vehicles Act, 1988 (59 of 1988) in this regard;

Now, therefore, the Governor of Mizoram is pleased to constitute an one-man Inquiry Commission for the aforesaid purposes and to appoint Pu Thanhawla, Joint Secretary to the Government of Mizoram, Environment and Forest Department, to the said Commission with immediate effect.

Terms of reference of the commission so constituted shall be as follows, namely —

- (1) to have an indepth study and analysis on the causes of the motor vehicle accidents which took place in the recent past including the four heavy passenger motor-vehicle-accidents which took place near Baktawng on 16/7/95, Kawnpui on 30.10.95, near Muallungthu on 11.11.95 and near Lengpui on 13.11.95 in particular, and to record the findings thereon;
- (2) to identify, record and enumerate all direct as well as indirect causes of such accidents, including instances of persistent deviations from mandatory provisions of the Motor Vehicle Act, 1988 and the Rules thereunder relating to public service vehicles, regular maintenance and control thereof, engagement of drivers etc. therefore, road safety etc.;

- (3) to suggest remedial measures against frequent occurence of accidents involving various types of transport vehicles and measures for rigid administration of vehicular laws, and
- to formulate the scheme as envisaged in section 135 of the Motor Vehicles Act, 1988.

While holding the inquiry, the Commission shall have the following powers, amely-

- (a) summoning and enforcing attendance of any person as witness;
- requiring the discovery and production of any document;
- receiving evidence on affidavits, if required; (c)
- (d) requisitioning any public record or copy thereof from any office, and
- (e) requiring any person, subject to any provilege which may be claimed by that person under any law or the time being in force, to furnish information on such points or matters as, in the opinion of the Commission, may be useful for or relevant to, the subject-matter of the inquiry.

The Commission shall submit its report within two months from the date sue of this Notification.
