- 2. Due to acute shortage of Govt. Bungalow for accommodating V.I.P's it is inevitable for majority of them to reside in this private residences. While some of them may have sufficient space for accommodating security personnel in the existing building, others may not have such space for the guard barrack. In certain cases there may be absolutely no site for construction of such barrack thereby necessitating hiring of private building in the adjacent locality. It has, therefore, been decided that guard barrack of sufficient area may be taken on rent at the rate to be fixed under normal procedure depending upon individual conveniences.
