BOUNDARIES OF LENGTENG WILDLIFE SANCTUARY

NORTH : The boundary starts from the point where Ngopa-Mimbung BRTF Road crosses Minpui stream (the branch of Tuila river). The boundary runs along Minpui stream upwards till it reach source of the stream and after crossing the ridge meets the BRTF road at Phulbial camp. Then the boundary runs in the southeast direction and meets the source of Pharsih river downstream till it meets the point where Kawlbem to Selam footpath crosses Pharsih river. From this point the boundary runs along unknown stream in the east direction till it meets Hmunpui mual peak. Then it follows another unknown stream till it meets Pharsih river. Then, it runs along Pharsih river downstream about 1 Km. till it meets the point where an unknown stream meets the Pharsih river.

EAST : The boundary then runs along the unknown stream upwards in the south west direction till it reaches a peak and then crosses footpath till it meets Leiva river. It then runs along Leiva river upstearn till it meet a point where unknown stream meets Leiva following this unknown stream upwards till it meets a sources of Luangmual river. Then following Luangmual river down stream till it meets Dimphai river. The boundary then runs along Dimphai river upstream till it reaches its origin.

SOUTH : From the above point the boundary runs along western direction and then follows Tuimai river till it meets Tuiphal river. Then along Tuiphal river downstream till it reaches a point where Tuiluai river meets Tuiphal river.

WEST : The boundary then runs along Tuiluai river upstream till a point near Leiawngkawn. From this it runs northwards till it meets footpath to Lengteng at Leiawngkawn. It then crosses footpath and runs along hill ridge till it meet Saibual peak. From this point the boundary runs down to northern slope and then runs along unknown stream till it meet Tuila river and BRTF road. It then runs along BRTF road till it meets starting point i.e. Minpui stream.
