OBITUARY

The 1st. May, 1973. The Govt. of Mizoram have learnt with deep sorrow the sudden and pre-mature death of Shri K. Laldailova, Area Administrative Officer, Thenzawl at the hands of a miscreant on the 30th. April, 1973 at 6:30 p.m. at Thenzawl.

Shri K. Laldailova joined the Assam Civil Service II in 1963 and worked as Block Development Officer at Hnahthial upto 1967. He was there after transferred to Dhubri as Sub-Deputy Magistrate in 1967. Again, he came back to Mizoram and served as Area Administrative Officer, Ngopa Grouped Centre in 1970 from where he was transferred to Thenzawl Grouped Centre as Area Administrative Officer in 1972. He occupied several important and responsible positions as a student in Shillong and elsewhere and took keen interest in welfare works.

Shri K. Laldailova endeared himself among the officers and staff and always proved himself a conscientious officer. The Govt. of Mizoram place on record their appreciation of the sincere services rendered by Shri K. Laldailova and convey their heartfelt condolences to the bereaved family.

The Lt. Governor of Mizoram is pleased to order that a Committee be constituted consisting of the following for the purposes of smooth working of the Public Works Department and speedy execution of works :—

- (ii) The President, Mizo Union Party — Member
- (iii) The President, Mizoram Congress Committee — Member
- (iv) The President, Mizoram Contractors Association — Member
- (v) Pu J. Lianchungnunga, Contractor, Thakthing — Member
- (vi) Pu Zahnuna, Contractor, Chaltlang — Member
- (vii) The Principal Engineer, Mizoram — Member
- (viii) The Deputy Secretary, Finance Department, Govt. of Mizoram — Member
- (ix) The Secretary P. W. D. etc., Govt. of Mizoram — Member, Secretary.

2. The Secretary P.W.D. etc., Government of Mizoram will act as the Member Secretary of the Committee, and place before the Committee the Government's proposal in respect of the following questions of principle governing the Public Work Department of Mizoram :—

- (a) Registration and classification of Contractors.

(b) System of accepting tenders, particularly the circumstances and manner in which the lowest tender may not be accepted.

(c) Review of the schedule of Rates.

(d) System for award of road Contracts, i.e. preference for lump-sum contracts againsts the present system.

(e) Step to check malpractices and corruption, including the question of giving power to Deputy Commissioners to check the work of P.W.D. in the field.

(f) Policy regarding purchases.

(g) Organisational structure and any other important procedural matters.
