EXECUTIVE ORDER NO. 15/73

No. LCF 11/73/22 (a), the 15th. 5. '73 In Continuation of this office notification No. LCF. 11/74/2 of dt. 11. 4. 73 and in exercise of Powers conferred under Rules 3 & 6 of the Pawi-Lakher Autonomous Region (Forest) Act 1954, the Executive Committee of the Lakher District Council is pleased to constituted all lands within 1/2 km, measuring from the water of Kaladan River along the same river within the area of Lakher District into a District Council Reserved Forest. No person shall be allowed to settle, cultivate, cut trees or Bamboos and set fire within and remove sands, quarries and any other Forest products from this Reserved Forest without obtaining prior written permission of the Executive Committee of the Lakher District Council.

Any person violating this order shall be punishable as provided by section 15(a) & (b) of the said Act.
