The Loan Scholarships are tenable for pursuing regular full time courses in Arts, Commerce, Science, Engineering, Technology, Medicine, Agriculture, Law and Education in any recognised day time Institutions only. These are not given for adhoc purpose.

The maximum limits of Loans will viry from Rs. 720/- per annum to Rs. 1,500/- per annum according to the course of study. These limits may however be increased by Rs. 250/- in case of students for Engineering and other Technical and professional courses.

The recovery of a Loan will be effected by monthly instalment commencing one year after the loanee secures employment or three years after termination of Scholarship whichever is earlier. No interest will be payable on the loan so long as the monthly instalments of the payment are plid on due dates. Interest will however be charged 6% in class of default. The Loan will be given without security or surety except to class of minors. The selected candidates will however be required to execute a bond with the Government to abide by the terms and conditions of award and repayment. Scholarship joining the teaching profession after the completion of their studies will be exempted from the repayment of loan.

## LLIGIBILITY

1. The Scholarships are open to Nationals of India only.

2. Students who passed any of the qualifying examinations which at least 50% marks will be eligible for consideration if the income of their parents/guardians from all sources does not exceed Rs.6000/- per annum.

- (i) For Post-Graduate study, loan scholarships will be paid without any consideration of the income of the parents of the candidates.
- (ii) In case of other courses only whose parents have an income of Rs.500/or below per month will be eligible for the scholarship.
- iii) For the purpose of Rule (ii) above the income in the case of salaries class; would mean basic salary plus income, if any, from other sources and would not include allowances like Dearness Allowance. In case of others, income would be the one assessable for purpose of income Tax.

3. Students who get Schelarships under any of the following schemes are not eligible.

- a) National Scholarship Scheme.
- b) Any other Scholarships Scheme of the Central Government.
- 4. Candidates in full time employment are not eligible.
- 5. The students who passed the qualifying examinations, Viz:
  - a) Final School Leaving Examinations and
  - b) Indian School Certificate Examination securing 50% marks in an earlier year are also eligible to apply.

6. For Post-Graduate stage mentioned under Rule II only those candidates who are successful in the Final Examinations held in the year of award will be considered. However, candidates passing B.A./B.Sc. or other eligible final Degree Examinations even in an earlier year will also be eligible.

Applications complete in all respect should reach the undersigned on or before 15th. November, 1973. Incomplete applications or application received after the prescribed date will not be considered.

The prescribed application forms may be obtained from the Principal of the Colleges concerned.
