1991. According to this Norms, a minimum service of 8(eight) years plus another 8(eight) years is required for placement to Senior Grade and Selection Grade respectively. In other words, a total of not less than 16 years is required for placement to Selection Grade.

And whereas the UGC has revised the Norms in 1998 and as per the new Norms, a minimum service of 6(six) years and 5(five) years is prescribed for placement to Senior Grade and Selection Grade respectively and according to the revised norms, a total service of 11 years is required for placement to Selection Grade.

And whereas the UGC, anticipating the hardship that may arise due to the change in the number of years of residency, has allowed placement to the next higher grade after adjusting the total number of years. (vide para 7.8.0)

OFFICE MEMORUNDUM

Subject: RECRUITMENT OF STAFF THROUGH EMPLOYMENT EXCHANGES.

No.A. 120319/1/90-L&E, the 7th February, 2008. Attention of all Departments under the Govt. of Mizoram is invited to the Labour & Employment Department Office Memorandum No. B. 12021/1/2006-L&E, dt. 20.9.2006 which inter-alia, provides that the vecancies, irrespective of the nature and duration arising under the State Govt. Offices/Establisharous including Quali-Govt. Institutions and local bodies other than those vacancies to be filled through either promotion or on the result of examination or interview held by statutory body like UPSC or MPSC, are to be notified and filled through the Employment Exchanges alone. Other sources of recruitment can be resorted to only if the Employment Exchange concerned issues a Non-availability Certificate.

2. The Employment Exchange procedure came under the judicial accrutiny of the Supreme Court in the matter of Excise. Experintendent, Andra Pradesh VS-K.B.N. Visweshwara Rao & Ors (1996 (b) SCALE 676). The Supreme Court, inter-alia, directed as follows:

"It should be mandatory for the requisitioning authority establishment to intimate the employment exchange and employment exchange should sponsor the names of the candidates to the requisitioning Departments for selction strictly according the to seniority and reservation, as per requisition. In addition, the appropriate Department or undertaking or establishment, should call for the names by publication in the newspaper having wider circulation and also display in their office notice boards or announce on radio television and employment news bulletins and then consider the cases of all the candidates who have applied".

3. Accordingly, it was clarified by the Govt. of India, Ministry of Personal P.O. & Pensions, Department of Personal & Training, vide their O.M. No. 14024/2/96-Estt. (D) Dt. 18-5-1998 that in additional to notifying the vacancies to the Employment Exchanges, the requisitioning authority establishment
