- B. Tenure of the Committee: Tenure of the Committee shall be 3 years from the date of constitution of the Committee which should count from the date of issue of formal Notification. The members of the Committee shall hold office at the pleasure of the Executive Committee of the concerned District Council.
- C. States/entitlement of Committee Members:-
- 1) Vice Chairman of the Committee shall be entitled to salary, TA/DA and all other facilities as EMs of the District Council.
