- Starting point : From the confluence of R.Beino (Kolodyne) and R.Kumai.
- WEST (P/No. 1 - 2) : From the confluence of R.Beino and R. Kumal, the boundary runs towards the south upto 1 Km. from starting points and runs along the India - Myanmar international boundary on R.Kumal and joints at R.Ralie and then runs along the R.Ralie by crossing P/No. 921/901 till it meets at R. Salyu.
- SOUTH - EAST (P/No 2 - 3) : From R.Salyu, the boundary runs towards the East Contiguous by R.Salyu till its meet at R. Tiko and R.Tolyu junction. Then the boundary runs along upstream of R.Tiko till it touches old Bymary Village hillock.
- EAST - NORTH (P/No 3 - 4) : From the old Bymary village hillock,the boundary goes on the periphery of the same hillock till it reaches the fount of R.Khoza.
- NORTH - EAST (P/No.4 - 1) : From the fount of R.Khoza, the boundary again runs along R.Khoza till it reaches its junction and from that junction, it again follows R.Khoza down stream and meet at the starting point i.e. the 3 confluence.
