In partial modification of this office Notification No. B. 16013/1/2007-EDC/130-134 dt. 12.9.2008 and in pursuance to the corrigendum issued by the MPSC vide No. 34/P/2008-MPSC Dt. 19.9.2008 conveyed by DP&AR(GSW) vide No. A. 32013/11/2007-P&AR(GSW) dt. 24.9.2008, the Governor of Mizoram is pleased to absorb Pi Janet Sangkungi Pachuau D/o Khawlremsanga to the post of Lecturer (Senior Grade), Department of History, Govt. J. Since L.Rashini Devi (Sl.No.2) has neither the minimum percentage of mark in Master Degree nor the qualification of NET, even though she joined her post prior to 12.10.1999 and the other 6(six) Lecturers (Senior Grade) at Sl.No. 1,3,4,5,6 and 7 who joined their respective posts after 12.10.1999, have not acquired the requisite qualification of NET/M.Phil, they have been provisionally absorbed into Govt. service. Had the qualification of NET/M.Phil been acquired by L.Rashini Devi, her deficiency in percentage of marks in Master Degree may be condoned by the Government.
