During the period of his suspension Shri A. Bhattacherize shall be paid a subsistance allowances at an amount equal to the leave salary which he would have drawn if he had been on leave on half average pay or on half pay, and in addition dearness allowances as admissible on the basis of salary.

ORDER BY THE ADMINISTRATOR

No. MC. 4/11/74/Pt. I, the 26th March, 1975. Whereas by order of the Administrator of the Union Territory of Mizoram vide Government Notification No. MC. 4/15/72 dated 1.9. 1974, the whole of Union Territory of Mizoram was declared as a disturbed area under the Assam Disturbed Areas Act, 1955 for a period of six months;
