Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Gentral Govt. or Govt. of Mizotam from time to time.

Disqualification.

No person, '

- (a) whohas entered into or contracted a marriage with a person having a spouse living, OR
- (b) who, having a spouse living has entered into or contracted matriage with any person, shall be eligible for appointment to the said post.

I. 72 are hereby repealed.
