No. L&ED 122/74/18, the 22.4.1975. In exercise of the powers conferred by the proviso to article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/11/71-H MT-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Employment Officer in the Employment Services Department Govt. of Mizoram,

- Short title and commencement
- (1) These Rules may be called the Mizoram Employment Service Deptt: (Class II Cazetted post) Recett, rules, 1975.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application. These Rules shall apply to the posts specified in Column 1 of the Schedule hereto annexed.
- 3. Number of Posts. The number of the said posts, their classification and the classification and scales if pay attached thereto shall be an specified in scale of Pay. Columns 2 to 4 of the Schedule aforesaid.
- 4. Method of Rectt. The age limit, qualifications and other matters relating age limit and to the said posts shall be an specified in column 5 to other qualification. 13 of the said Schedule.

Provided that the upper age limit prescribed for direct rectt, may be relaxed in the case of candidates belonging to the Schedule Castes, the Scheduled Tribes and other. Special categories of persons in accordance with the orders issued by the Central Govt or Govt of Mizoram from time to time.

No person:

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

 Training and Departmental examination Every Government servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.

7. Power to relax

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provision of these rules with respect to any class or category of persons,

Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. of Govt. of Mizoram from time to time. regard.
