- Shore title and These Rule may be called the Milloram Leonomies and commencement. Statistics (Class III posts) Recruitment Pules, 1973.
 (2) They shall come into force on the fate of their pulsilication in the Official Gazette.
- Application. These Rules shall apply to the post specificit in column 1 of the Schedule hereto annexed.
- Number of post. The number of the said posts, (hair of aircation and the Classification scales of pay attached thereto shall be as specified in and scale of pay Columns 2 to 4 of the Schedele afores dd.
- Method of rectt The age limit, qualifications and other mutters relating age limit and to the said posts shall be as specified in columns 5 to 1 other qualification of the said Schedule.
