Boundary description of the said reserved forests as follows :---

1) CHONGRASURY RESERVED FOREST :— Chongrasury reserved forest starts from a small river called Chhotapansury in the North and then it goes up to Gerakuluksora which is also a small river in the Southern boundary of the reserved forest. In the East it start from the Govt. Jeep road constructed in zik zak way from Borapansury to Jarulsury. In the west, it starts from river Thega which is the western boundary of the reserved forest as well as an International boundary between India and Bangladesh.

2) SILSURY RESERVED FOREST :- This reserved forest also starts from a small river called Pankodasora in the north and then it goes up to a hill slope which is also an International boundary line between India and Bangladesh in the South. In the west it starts from Thega river, the same Western boundary line of Chongrasury and Silsury reserved forest, In the east it covers one K.M. from the river bank of Thega.

Untill the Chakma District Council has framed forest rules of its own these two reserved forests shill be maintained under the provision of P.L.R.C. forest Act. 1954.

The above reserved forests do not include the supply and safety reserves proposed by the Village Councils constituted within the Jurisdiction of CDC.
