In supercession of the Executive Order No. 16 of 11.12.78 conveyed under this Office Memo No. PCR 11/78/183 of 11.12.78, the Executive Committee of the Pawi District Council is pleased to refix the value of Land under the jurisdiction of the Pawi District Council and the rate of the Land Revenue thereof payable by persons holding such Land or Lands under Certificate of Land Settlement. Classification of Lands.

- Grade 'A' (1) From Luidhaiber along the BRTF road (both sides within radius of 30Mtrs from the road) upto Pu Tanmanga's Land Settlement.
- (2) From Traffic Island towards Kolodyne along the PWD road (both sides within radius of 30M. from the road) upto the Council Office approach road.
- (3) From Traffic Island towards Lawngtlai Vengpui (both sides within radius of 30M. from the road) along the PWD road upto Vanmawia's house.

Grade 'B' (1) From Luhnaber along the BRTF road towards Balhlakawn (both sides within radius of 30M. from the road) upto the end of Town Area.

(2) From Pu Tanmanga's Land Settlement towards Chawthu along the BRTF road upto the end of Town Area.

Grade 'C' (1) All Lands along the PWD and Council roads or any other Jeep-able street road, within Lawngtlai, Bualpui (Ng) Diltlang, Sangau and Chawngte Town Area. Land along the BRTF roads (both sides) within the radius of one km. from the BRTF road.
